AN ORDINANCE TO AMEND CHAPTER 2 FIRE PREVENTION AND SAFETY CODES OF TITLE 3 PUBLIC SAFETY FOR THE TOWN OF BURKE, DANE COUNTY, WISCONSIN

SECTION 1: the Town Board of supervisors of the Town of Burke, Dane County Wisconsin does hereby ordain as follows:

TO AMEND TITLE 3 CHAPTER 2.2(a)

Whereas, the Town Board acknowledges the update of State of Wisconsin Fire Codes and the transfer of regulatory agencies from the Department of Commerce to the Department of Safety and Professional Services.

3-2-2 ADOPTION OF CODES

adopted as part of this Chapter 2.

SECTION 2: Now, therefore, be it resolved that the Town Board of the Town of Burke, Dane County, Wisconsin repeals the above chapters from Title 6.

Effective Date. This ordinance shall take effect and be in force from and after its passage and publication as provided by law.

Severability and Conflict. If any section or part of this Ordinance is adjudged unconstitutional or invalid by a court of competent jurisdiction, the remainder of this Ordinance shall not be affected thereby.
